### **Ioflupane Checklist:**

- The group is progressing the Consensus I-123 Profile (Stage #2) toward the technically confirmed phase
- Tasks remaining include:
  - Utilizing normative text to create a conformance checklist
    - Drs. Dewaraja, Dickson, and Obuchowski to meet offline regarding the claims on 9/25
    - Bias and putamen ratios to be discussed
    - Additional data will be available by this time, as 9/29 is the due date for groundwork project reports
    - Dr. Dewaraja to upload raw data to the QIDW for others to review
  - Creating firm timelines for claim revisions
    - Updates to be discussed on the I-123 TF call, 10/3
  - o The BC intends to have a new Profile version ready for discussion by the face-to-face meeting at RSNA 2017
    - A conformance checklist will follow from the profile
    - Conformance testing for ioflupane is being planned with minimum thresholds under consideration for inclusion

## RSNA 2017 Poster:

- Threshold for the number of calls to be included on the poster is TBD
