 - A separate announcement with specialized language was sent to subject matter experts, e.g., ASFNR contacts submitted to RSNA staff & ISMRM Brain Function Study Group members
 - o In efforts to broaden circulation, the announcement noted that recipients may forward the request-to-review to additional colleagues who may be interested
 - Public comments to be collated and addressed after the close of this stage, but fMRI BC leadership may request status updates throughout the public comment period
 - While content of this Profile has a narrow focus, it is valuable as a first step in standardization in fMRI
- Checklist to test feasibility of Profile to be drafted and feedback will be sought; ASFNR engagement expected
