## 1. Update on the QIBA Group 3A Challenge

Dirk Colditz, PhD

- No new participants or data received; reminder regarding the deadline for data submission was sent on 2/16/2012 and 2/23/2012
  - o Data submission deadline- Wednesday, February 29, 2012
    - "soft" deadline data will be accepted even if participants go past 2/29
  - Analysis/ results extended to Wednesday, March 28, 2012

## 2. Discussion of Technical Questions from QIBA 3A Challenge – Pilot Participants

- Confusion in terms of coordinates when using DICOM and embedded patient coordinate system clarified
- Hounsfield Unit (HU) discrepancies: manufacturing differences, differences in CT computational process
  - o Mr. Dima suggested that participants treat the images as data
  - Relative percent errors on the radar plots were also discussed
    - Careful analysis is required when involving different nodule sizes and shapes
    - Reordering may result in better continuum possibly more natural pooling of nodules

# 3. PIVOTAL study rollout

- Dr. Saiprasad has prepared 408 lesions in a pivotal set additional cases are available if needed
- Drs. Kim and Lu are working on the power study to discuss on the next call, March 8<sup>th</sup>
  - o Power study to focus on specific criteria provided by Dr. Athelogou
  - o R-scripts to be included
- Overlap expected between the statistical analysis of pilot data and preparation for the pivotal study
  - o Team members may have to be assigned to keep the projects moving forward
- Pivotal study documents will be edited to reflect lessons learned from the pilot study
  - o Guidance language to be incorporated based on technical questions reviewed from pilot study— updates will be handled by Mr. Dima and Mr. Buckler

#### 4. MICCAI update

Dr. Athelogou will work on preparing documents needed to apply for the conference as presenters
