4. New template for Profile discussed with focus on new claim construction

- Suggested adjustments and edits were made to the claims wording based on the distributed document: "Proposed Names for QIBA Profile Stages."
 - o Clarification needed for meaning, purpose, and group goals
 - Main goal is "to localize eloquent cortex"
 - Biomarker must be a physical quantity that can be measured
 - Details to be worked out with regard to bias, accuracy, reproducibility and precision.
 - Bias must be discussed in terms of BOLD reproducibility.
 - No final decision yet on the consensus biomarker, though Dr. Voyvodic indicated that he would draft wording using the new claim template and circulate to the group for consideration.
