Discussion points:

- Dr. Samir's standardized case report forms on guidelines for using pooled data are available for use. Any feedback may be sent to: ASAMIR@mgh.harvard.edu
- A UPICT protocol for clinical use is also planned for release for public comment by the end of May; A steatosis report should also be available by the end of May
 - Papers with summaries of key findings have been compiled in an Excel spreadsheet; available via DropBox

Clinical study update:

- Patient recruitment will likely exceed the 80 person goal by October. There is an interest in clinical data with underlying RF data, and equivalent measurements across multiple systems to understand bias and variance; an interim analysis is expected by late May.
- Data from an Echosens Fibroscan device would be desirable but may add cost
 - Repeatability and reproducibility studies with these measurements should be included
 - Measurements through all stages of cirrhosis would be helpful, normal through fully cirrhotic patients
- Dr. Palmeri has newly acquired, clean visco-elastic datasets with calibrated data for humans that will be accessible via the QIBA wiki soon
 - Dr. Palmeri will provide some suggested parameters for a successful simulation for group feedback

QIDW Update

- Drs. Barr and Cosgrove have agreed to upload images and will coordinate with Dr. Andriole
- Dr. Samir discussed a research registry called, "RedCap," which is on a HIPAA-compliant host server
 - It is unclear at this time whether this would be used in lieu of or in conjunction with QIDW
 - o Drs. Samir and Dhyani to confer with Drs. Andriole and Bresolin
