## **Phantom Project Update**

- Data from UC Davis undergoing analysis by Dr. Ashton
- Dr. Jackson plans to have cohesive set of data for presentation to group on January 19.
  - o Group to make decision to wrap up project or collect additional Philips data at that time
- Proposal for New QIBA phantom production submitted to QIBA for consideration

### **Project Proposals**

- Five proposals submitted to DCE-MRI Technical Committee for consideration
- After completion of review and scoring process, QIBA Steering Committee will prioritize all proposals to help with funding decision
- Funding decision expected by early February

#### **Profile Discussion**

- Sections have been completed and final draft is now ready for work on references
  - Currently, high-level sections citing 25+ references
    - Need to reduce to 4-5 seminal papers
    - Suggest citing a few prominent review articles that include more comprehensive references; will help avoid author bias
  - Similar approach needed in technical sections
    - Need input from clinicians
  - Drs. Gupta, Jackson, Rosen and Knopp to help with this task
  - o Imaging protocol section needs additional references
    - Recommend including methods to meet test/retest Claim
  - Guidance on T1 values needed
    - May need to review literature for appropriate models for inclusion
  - Revised references due to Dr. Gupta by 1/10
- Dr. Gupta to merge reference revisions and disseminate to DCE-MRI Technical Committee for review
  - o Goal to complete final review by 1/19 in preparation for release for public comment period
  - Reviewers should check that previous centric focus on abdominal application has been broadened sufficiently

#### **Public Comment Period**

- Public Comment procedure needs clarification
  - To be discussed by QIBA Steering committee, as applicable to all modalities
- Suggestion to issue invitation to include announcement of public comment period, identification of location of document, process for submitting comments, invitation to share with experts in the field
- First step to develop a strong extended contact list to include specific names of known experts
  - o Proactive approach to supplement open call
  - o Dr. Knopp to facilitate sharing list with ISMRM for additional input
    - ISMRM Cancer Study Group most applicable resource
    - List should include representatives from all stakeholder groups
      - Academics, clinicians, hardware and software manufacturers, and pharma
- Time limit of public comment period needs to be defined

- o Currently 30 days with and additional 30 days to resolve any issues
- o Consider having some overlap, if necessary
- RSNA staff to organize alias e-mail for profile feed back
  - Recipient list tbd
