Review of Previous Meeting Summary:

Discussion Topics

- Multisite analysis DRO project data and reproducibility study updates
- QIBA fMRI Language-Mapping Profile 2.0

Action Items

- Multisite analysis DRO project data and publication
 - \circ $\;$ Issues with data from a couple of sites were identified and fixed
 - Dr. Voyvodic analyzed activation maps, calculated statistics for the reactivations, and documented differences between sites
 - Laterality maps, locations of activations, cluster centers and peaks were similar across sites, but not identical; a final comparison will be done after registration
 - The author list of this paper will include those who have analyzed data and/or been involved in related discussions
- A bug in the reproducibility study cluster algorithm was identified and fixed; clusters will be regenerated for an improved result
- While the fMRI Profile will be refined and finalized, it will not be advanced past current Profile development (Stage 0), i.e., it will not be disseminated for public comment
 - o Clarification was provided regarding an activation quality control specification
 - o Duplication between Section 4 Assessment Procedures text and Section 3 tables was reduced

- Staff to ask fMRI BC members if they would like to opt in of receiving email communications following the Dec. 22 QIBA transition to QUIC
- Dr. Voyvodic to send multisite analysis DRO project data to Dr. Talekar for his review
- Dr. Voyvodic to consult Dr. Obuchowski regarding the confidence interval aspect of Reproducibility Claim 2
- Dr. Soltysik to send the latest version of Profile to Dr. Storrs who will finish edits by Dec. 11 and send to staff for circulation
- The Profile will be posted on the dedicated fMRI Committee page once it is finalized
- The last RSNA staff-supported meeting will be held on Wednesday, December 20, at 11 a.m. CT
 - fMRI efforts to continue as an independent Profile-writing group after Dec. 22; Dr. Mohamed to look into hosting bi-weekly calls through his institutional Zoom account
 - Call frequency may be reduced to a monthly basis once the Special Report has been completed
