### **Maintenance Process and Profile Edition & Version Guidance**

#### **Naming Convention**

- Title pages of all future Profile publications to reflect the following <u>standard nomenclature</u>: <Modality> <Biomarker Name> <Publication Date> (Stage) [<u>examples</u>], to be publicized to BC Co-chairs
- Consensus was that updating current Profile names was NOT needed; nomenclature updates can be made when a Profile advances to the next stage, or is republished due to maintenance updates
- The following bullets will be added to the <u>Publication Process QIBA Wiki page:</u>
  - To author checklist: title page of Profile should reflect standard nomenclature
  - $\circ$  To staff checklist: confirm that Profile title page aligns with current stage name guidance

## **Tracked Change Process**

- Maintenance Process
- Profile Change Log to be highlighted as the location to refer readers to key areas in the Profile to review; noting implications/significance (release notes) to be considered
- DCE and DSC BCs are seeking PC guidance for republishing their stage 2 Profiles after updating recommendations based on updated supporting literature
- Criteria are needed regarding what constitutes "editorial change" (not requiring CC approval) and what requires initiating an approval process
  - $\circ$   $\,$  BCs to request CC input re: whether BC and CC voting member approval would be needed

## Profile Renewal, Revision, Retirement process

- CC leaders need to be familiar with all Profiles under their modality
- CCs review Profiles every 5 years to assess effort required, BC activity, etc.
- Suggested criteria, guidelines, checklist, elements to discuss, etc. to be developed
- Staff to track when reviews need to occur and notify CC Co-chairs
- Would be a CC responsibility, with BCs contacted as needed
- Mr. O'Donnell to propose draft process for SC consideration during their May 9 in-person meeting

## **Profile Editors Meetings**

- To be held to address questions from new BCs or BCs approaching milestones and/or experiencing challenges
- Meeting including representatives from DWI, fMRI, PET Tau, Hyperpolarized <sup>129</sup>Xenon MRI BC (pending SC approval), and PEQUS focused on implementing the streamlined Profile template to be organized after the March 16<sup>th</sup> SC meeting
- Suggestion to reach out to all ultrasound BCs
- Repurposing Profile editors meeting recordings to address recurring BC member questions to be considered
