DCE-MRI Profile Status (Dr. Guimaraes)

- Dr. Guimaraes provided an overview of the compliance section of the DCE-MRI Profile (v2.0), modeled on the FDG-PET and CT VOL Profiles, as well as the ACRIN 6701 Protocol
- The skeleton compliance document is currently separate from the Profile and will be posted on the QIBA WIKI.
- The goal is to have the committee review the document, help assign tasks/ responsibilities to various "actors", then send feedback to Dr. Guimaraes and discuss the changes via e-mail.
- Challenge remains to identify the Profile audience based on the original intent for this document
- The proposed changes will be incorporated by the Feb 5th PDF-MRI Tech Ctte t-con.

DWI Phantom Update (Dr. Boss)

- Dr. Boss reported that the DWI Phantom will not be part of the IMI Clinical Trials at this point.
- Collaborations will continue with IMI in other areas.
- Dr. Boss received the alternate vials from Dr. Chenevert for testing.
- 4-5 revised phantoms will still be 3-D printed for TC use.
- Dr. Kirsch will forward the acquisition protocols for Siemens scanners to Drs. Boss, Chenevert and Guimaraes for formatting edits.
