Profile Review Process

- Discussion on the procedure for extending a public comment period
 - The intent of setting a deadline is to bring in comments promptly, but if further outreach needs to be done, it can be extended (timeline flexibility is critical to gather robust comments)
 - For example, the timing of the ASFNR meeting is after the original public comment deadline for the fMRI Profile, and fMRI members plan to attend the meeting and perform outreach there
 - Extending the deadline would provide another opportunity for ASFNR members to comment
 - Profile writer or BC leadership to notify RSNA staff that the group would like to extend the public comment period and provide staff with the new end date
 - RSNA staff to update the public comment form at: http://tinyurl.com/QIBA-Public-comment-Form so that the Profile name appears as a drop down item
 - RSNA staff to send out a public comment announcement with a new deadline to 1,000+
 QIBA Members and 100+ sister association contacts and SMEs provided by QIBA group leaders
 - When public comment period has closed, the Profile name will be removed from the public comment form and Profiles page of the QIBA Wiki at: http://qibawiki.rsna.org/index.php/Profiles to be updated
 - Comments to be collated into Google Sheet for an efficient, collaborative comment resolution process
