## DCE Profile Update (Dr. Laue)

- o Dr. Chung reformatted the DCE Profile section text to mimic the DWI Profile
- Dr. Laue replaced equations and images lost during the translation between Google Doc to MS Word versions
- $\circ$   $\;$  Reference page numbers in table of contents to be updated
- The Profile change log has not been consistently used, but Google Docs contain version history which documents changes
- Changes between DCE Profile v1.0 (2012) v2.0 (2019) were described in Section 1 of the Profile
- Dr. Nayak to upload Round-6 project B1 maps (of static phantom) from different scanners (including specific sequences utilized) to the Quantitative Imaging Data Warehouse (QIDW); links to QIDW for B1 reference data, DRO R1 phantom software/data to be added to the Profile
- Grammatical changes were made to Section 2: Clinical Context and Claims (formerly "Clinical Trials and Claims")
- Claims in Section 2.1: Clinical Interpretation have not changed, but the page was reorganized to be consistent with the DWI Profile
- A high-level review of the DCE Profile v2.0 to be requested from Drs. Boss and Zahlmann
- Section 3: Profile Activities
  - Tables were updated and content was added to Section 3.1.1: Staff Qualification (discussion section) re: image analyst
  - Dr. Boss to be consulted on Section 3.3.2: Pre-delivery specification table re: scanner requirements for DCE
  - DCE BC members were asked for feedback on Section 3.4: Installation, subsection on Software re: B1 maps, parallel imaging and view sharing
  - Feedback on T1/R1 Phantom scanning and T1/R1 Precision text was requested
    - Characteristics and specifications of technical abilities of phantoms and/or software were provided
    - High-level text will remain where it is, specifics regarding T1 or R1 reference values or ranges to be moved to Section 4.1: Assessment Procedure: R1/T1 Mapping accuracy
  - Discussion occurred regarding use of a flow phantom
    - There is no consistency in flow phantom usage across the field today
    - Use of a flow phantom will not be included in the conformance checklist nor will it appear in any specification tables

- Flow phantom to be included in discussion section of Section 3.5: Periodic QA for the purposes of informing and educating the community, as well as to increase awareness
- In efforts to finalize the Profile, DCE BC members were urged to review it and make additional comments; a note will be included with the call-in details email for the March 4 DCE BC call
