General Discussion

Update on QIBA Annual Meeting, May 21-22, 2014

- Key points from the Plenary Session were overviewed by Dr. Sullivan
 - o Dr. Pyenson: The Concept of "Value" as Payers Implement It: CT Screening Example
 - Background of the role Quantitative Imaging plays in lung cancer screening
 - Mr. O'Donnell: Update on QIBA Compliance relating to IHE and ACR Accreditation
 - Dr. Ford: Imaging CRO's Perspective re: QIBA
 - o Dr. Hoekstra: EANM Example
 - Update of EANM accreditation progress

2015 NIBIB Project Proposal Status

- Dr. Shao shared the project proposal score sheet and overall status of FDG-PET Projects
 - o Dr. Kinahan emphasized that the comments listed did not reflect the overall SC view
- The next project edits are due to the RSNA by July 7th for review by the SC on July 17th

Project Updates

- Profile Field Testing
 - Drs. Turkington, Boellaard, Lodge and Kinahan are working through 125 outstanding items which have been mitigated to one spreadsheet
 - The items will be distinguished as to whether or not they are feasible for testing
 - A request was made for the group to present examples of how the items are being broken down and analyzed/classified, e.g. 10-15 items, within the next two weeks
 - Non-essential items for project compliance checklist to be removed

- DRO Project update
 - The data have been submitted for a revised *Radiology* manuscript
 - The DRO was reviewed
 - New developments/additions to the DRO have been implemented and will be tested soon.
 - Dr. Pierce shared slides to update the groups' progress
 - 6 different region of interest tests have been performed
 - 22 sites have recorded data
 - Placement of ROIs, testing tool functionality, as well as measurement of voxels, was discussed
 - The intent is to publish an answer key which will include threshold
 - Possible role for DRO in Profile Compliance to be discussed
- Amyloid Writing Group Update
 - o Dr. Smith updated the group with developments from the recent SNMMI 2014 in St. Louis
 - Dr. Smith will reach out to Maria C. Carrillo, PhD, Senior Director, Medical and Scientific Relations Alzheimer's Association, re: a potential collaboration with <u>GAAIN</u> (*The Global Alzheimer's* Association Interactive Network), an online repository of federated Alzheimer's disease research data that will transform the way neuroscience data is shared and accessed by scientists around the world.
 - o The Test-retest subgroup t-con is scheduled for next week and will be led by Dr. Frey
