#### Brief Updates from Phase 1 NIBIB Subcontract Recipients

- MD Anderson CC - Phantom project update nearly on track (Dr Jackson)
  - Phantom Labs contacted with phantom drawing for fabrication quote
  - Machine drawing modified by Josh Levy and returned with suggestions to reduce cost and make more robust (for possible future commercial production)
  - Dr Jackson to finalize changes within a week
  - Filling solutions to be mixed/added at MD Anderson CC
- VirtualScopics - Software development to analyze phantom data on track as well (Dr Jackson for Dr Ashton)
  - Deliverable will be executable, not source code; still need all algorithm details defined
  - To be used to analyze data obtained with QIBA DCE-MRI phantom testing
  - Guideline for data acquisition in-hand for GE, Philips and Siemens scanners
- Duke University - Synthetic Data Project Update (Dr Barboriak)
  - QIBA sub-award executed and full project effort underway; programmer and physicist already engaged
  - Request to post synthetic data to Wiki (currently on the Barboriak Laboratory website)
  - Dr Jackson to provide ranges of T1 & R1 represented by phantom
  - Small ad hoc work group proposed to focus on synthetic data project; need input
  - September T-con of all interested to be coordinated to discuss forward direction and real-world use; how to provide synthetic data for T1 and R1 measurements
    - Dr Barboriak to draft email language that staff can send requesting participation (describing interest) to all DCE Tech Ctte membership
  - Need to outreach to vendors, if possible

#### Update on Phase II NIBIB Subcontract (Dr Rosen)

- UPenn Update – Test/Re-test Patient Prostate Study (Dr Rosen)
  - Protocol concept finalized for human test/re-test prostate study in conjunction with ACRIN
  - 30 patients across 6 sites proposed with data analysis being done at ACRIN
  - Details of image analysis still being determined by Dr Rosen
  - Dr Jackson to be co-PI on technical aspects
  - Protocol to be wiki posted for group reference and feedback (no proprietary concerns from UPenn)
  - Protocol feedback needed re: feasibility; logistical and clinical details still required; participating sites need to be identified
  - ACRIN still discussing details of NIBIB (QIBA) sub-award; proposal not approved yet
  - In-person working group proposed for ACRIN fall meeting to work through details
  - Contact with QIN proposed: Drs Rosen, Jackson, Lawrence Clarke and David Mankoff
