Review of Previous Meeting Summary:

The 12.07.2022 meeting summary was approved as presented

Topics Discussed:

- Timeline for first Profile draft
- Remaining open Profile issues

Next Steps / Action Items:

- Discussion on Fig 1 in Section 1.1 Clinical Context: mapping the primary language areas for use in planning and guiding brain surgery or radiation treatment
 - Focus is on reproducible data in only the critical language areas in this first Profile iteration; supplemental language areas may be included in a future version
 - This figure is based on Dr. Voyvodic's data reanalysis and should be considered final
 - Linking to DICOM or NIFTI files that could be downloaded for a clearer view of the image was suggested
- Dr. Voyvodic to check values in Reproducibility Claim 1 and examine confidence intervals for the activation peak
- Section 3.4 Image Analysis Tool Checklist: while not required for meeting Claim, discussion about visible inspection and threshold adjustment best practices to be added
- Section 3.10 Conformance Testing Checklist: discussion re: DROs and tools for performing conformance testing
 - 10 DROs are available for download in the QIDW, but 30 pairs of scans from the same session are needed
 - Links to DROs and atlas as well as software tools, e.g., SPM scripts, Nordic plugins, or a standalone tool, etc. would need to be made available
 - Dr. Talekar to discuss with his team, performing image analysis steps, including computing specific locations of peaks or centers of mass values, using an SPM standalone tool; Dr. Voyvodic will make the DROs available for download on his website
- Work is still needed on Section 4: Assessment Procedures
- Dr. Storrs to edit text in Appendix A.9 and Dr. Soltysik to reformat references
- Dr. Pillai made edits to Appendix B and staff will distribute latest version of the Profile for fMRI BC review
- The first Profile draft deadline has been extended; later steps include:
 - Release Profile to BC subgroup to evaluate checklists
 - Circulation for full BC review and a vote-to-release for Stage 1: Public Comment
 - MR CC vote-to-release will follow
