### QIBA 3A Challenge

- Mr. Buckler provided a brief update of the 3A Challenge
  - Application to participate and data submission deadlines extended
  - Dr. Carson to investigate whether U Mich plans to participate
  - Merck also planning to participate
- Update on Subgroup Projects
  - Group 1A - Dr. Petrick
    - A draft publication is being finalized and proposed for circulation in early 2012
    - T-con proposed for Drs. Kim, Petrick and Mr. Buckler to discuss the analysis plan
  - Group 1B - Dr. McNitt-Gray (extension of Round-1 project)
    - Drs. Kim, Clunie and McNitt-Gray will lay out phase 2
    - T-con proposed for early next week to discuss next steps
    - Reading to begin in 2012
  - Group 1C - Dr. Fenimore
    - Progress is being made and the group is meeting Thursday, Dec 15, 2011

### QIBA Vol-CT AdvDisease v2 Public Comment Profile Feedback (led by Mr. O'Donnell)

- Mr. O'Donnell reported that there are 48 low priority comments, 96 medium and 23 high priority comments and many still need to be addressed
- #20 (line #173): Use of the word "subject" rather than "patient"
  - A sentence will be placed at the beginning of the document noting that the word subject may be used to refer to patients through the Profile
- #22 (line #194): Specification
  - Make it clear that the goal is to populate anatomy in the image header
- #70 (line #113): Actor listing
  - Instead of "include the following" just use the word "are"
  - The complete list of actors should be in a table
- #71 (line #118) Replace "components" with "activities"
- Lines 127-129: Discussion to modify or delete language
  - Decision by Drs. Mozley and Clunie is to keep the content but eliminate the action item
  - Dr Steinmetz to clarify the language so that the Profile is not seen as a guidance document for clinical care
  - IRB expert to review this language as well
- #77 (line #145): Mr. O'Donnell to propose content wording

### Next steps:

- Proposed Public Comment Resolution
  - Mr. O'Donnell to allocate tasks for specific committee members to divide and conquer:
    - Dr. Mozley to address the clinical trials issues (12 issues)
    - Dr. Steinmetz to address the radiology issues/questions
    - Next call scheduled for Monday, Dec 19<sup>th</sup> at 11 am CST (no calls on Dec 26 or Jan 2)
